### **Rules & Regulations for Player Protection**

- A representative of team named above must detach this top portion of this Protection Sheet and return it to F.O.R Football in person.
- Signed Player Protection Forms are accepted from January 1 of current year until one (1) hour before the draft of the same year.
- Upon receiving player protection form, an authorized F.O.R. representative will initial, sign and date.
- Protects are granted on a first come basis pending all qualifications have been met, agreed to and sign by all parties involved.

#### **INFC RULES**

#### ***Article X - Section 4: Team Drafts - Subsection (C)***

- Upon origination (1<sup>st</sup> Year) a team may recruit and protect four (4) players from the draft. Each year thereafter, the team will be allowed to recruit and protect two (2) new players. The protected players cannot have played for another INFC team the previous year. This provision does not, however, eliminate the requirement that teams be of equal ability. At any time one team splits to two or more teams, all players will be in the draft pool except the four (4) protected players.

#### ***Article X - Section 4: Team Drafts - Subsection (H)***

- Before leaving the draft table, coaches will be allowed to trade players but only those players that were selected during the draft. Existing or protected players are not tradable....

#### **Article X - Section 7: Team Drafts**

- A player that leaves an organization but returns the following year will be in the draft and cannot be protected.

#### **Article X - Section 9: Transfers or Releases**

- Players that are granted transfers must be placed in the draft and may not be a protect from the draft.

The above rules are taken from the 2008 INFC Official Rule Book. These rules are meant only as a guideline and not as final say. It is up to you and your coach to comply with the current rules and regulations regarding Future Owasso Ram Youth Football and the INFC as they pertain to your son, your player and the Player Protection Rules.
